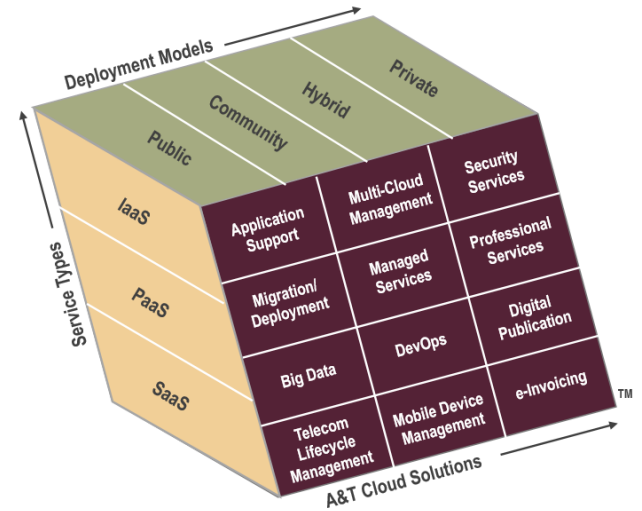

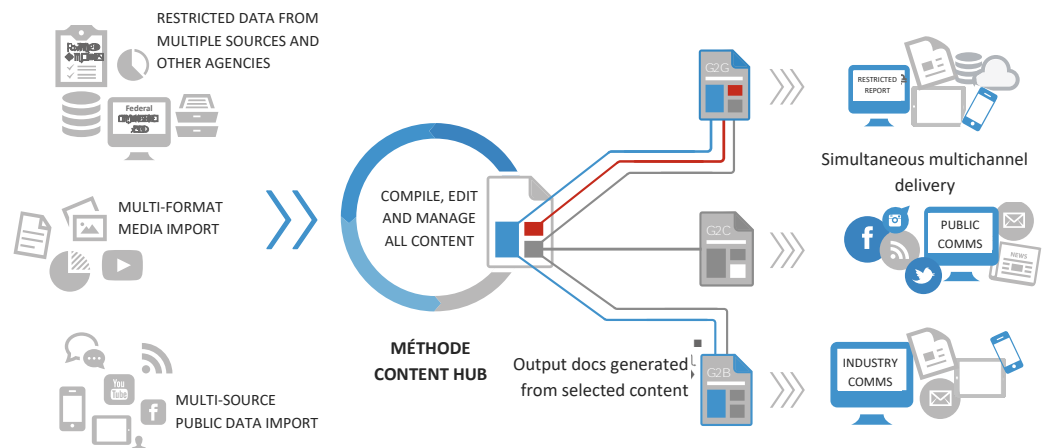
Méthode vs. Standard Office Apps

Task	With standard office apps	With <i>Méthode</i>
Collaborative authoring	Multiple versions of document, cut and paste	Single document, real-time view of edits
Using images and other media	Manual reformatting for each content stream	Multiple formats generated on intake – correct format selected automatically for each channel
Reviewing and approving	Workflow coordinated by phone calls, emails and “shouts across the office”	Reviewers receive material in their inbox; automatic release on approval
Multi-channel publishing	Manual “repurposing” for different channels.	Auto-format and one-click publishing for all channels

What about the User Interface?

Users can access the *Méthode* workspace using a variety of devices from desktop to mobile. Browser and app-based clients need no installation or maintenance on user platforms.

Authors use a clean, user-friendly, MS Word-like interface to create media-rich content and deliver it through multiple channels from web to print, mobile apps, and social media.
